- 2. Discussions about China representation (not a single registration was received from China this year, maybe because of travel restrictions) and student rates (the reduced rate was instrumental in attracting many students)
- 3. Budget overview and VAT-related issues
 - o Some delegates want to recover the VAT. Since BioEM 2023 Ltd and BioEM society both are educational and not for profit organizations, they are not VAT-liable, this request was denied. An expert was appointed to investigate whether BioEM 2023 Ltd indeed is not VAT-liable. If we are, there would be an additional cost of £10,000, but the likelihood of this is low.
